TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (the "Termination and Release") dated as of February 25, 2008, from CRYSTAL CAPITAL FUND, L.P., as Administrative Agent (the "Administrative Agent") for the benefit of itself and the other Lenders (as defined in the Credit Agreement as defined below) to GTSI CORP., a Delaware corporation ("GTSI"), GTSI FINANCIAL SERVICES, INC., a Delaware corporation ("GTSI Financial") and TECHNOLOGY LOGISTICS, INC., a Delaware corporation ("Technology") (together with GTSI and GTSI Financial collectively referred to herein as "Grantors" and individually as a "Grantor").

WITNESSETH:

WHEREAS, pursuant to (a) that certain Credit Agreement, dated as of June 2, 2006 (as amended or otherwise modified from time to time, the "Credit Agreement") by and among Grantors, the Persons party thereto as guarantors, the financial institutions from time to time party thereto as lenders (the "Lenders"), and the Administrative Agent and (b) that certain Security Agreement, dated as of June 2, 2006 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement") between the Grantors and the Administrative Agent, for the benefit of the Lender Group, Grantors entered into the Trademark Security Agreement dated as of June 2, 2006 in favor of the Administrative Agent, for the benefit of the Lender Group ("Trademark Agreement"), which was recorded with the United States Patent and Trademark Office on June 5, 2006 in Reel 3321 and Frame 0668;

WHEREAS, pursuant to the Trademark Agreement, the Grantors granted to the Administrative Agent, for the benefit of the Lender Group, a security interest in the trademark registrations and applications listed on Schedule A attached hereto (collectively, the "Trademark Collateral"); and


WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Lien upon all of its right, title and interest, in to and under the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Definitions. All capitalized terms not defined in this document shall have the meaning assigned to them in the Security Agreement or, if not defined therein, in the Credit Agreement.
2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Lien upon all of its right, title and interest in, to and under the Trademark Collateral without representation, warranty or recourse of any kind or nature.
