3. Assignor further agrees to execute and deliver, from time to time, all further instruments of conveyance, assignment and further assurances, and to perform all such other acts, as may be reasonably required to transfer and assign all of Assignor's interests in and to the Marks.
4. Each of the parties represents and warrants that the person executing this Agreement on its behalf has actual authority to execute this Agreement and to bind that party to the terms of this Agreement .
