GLOBAL ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

THIS GLOBAL ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS is made, executed and delivered as of February 28, 2008 ("Assignment") by and between Constellation Wines U.S., Inc., a New York corporation ("Seller"), Constellation Brands, Inc., a Delaware corporation, ("Constellation Brands") and The Wine Group LLC, a Delaware limited liability company ("Buyer").

WHEREAS, Seller and Buyer have entered into an Asset Purchase and Sale Agreement, dated as of January 22, 2008 (the "Agreement"), pursuant to which Seller has agreed to sell, convey, assign, transfer and deliver, and Buyer has agreed to purchase, Seller's entire right, title and interest in and to the Intellectual Property (such term and all other capitalized terms used but not defined herein having the same meanings ascribed to such terms in the Agreement), all as more fully described in the Agreement; and

WHEREAS, Seller and Constellation Brands wish to transfer to Buyer the Intellectual Property and Buyer wishes to acquire the Intellectual Property.

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged and accepted, Seller and Constellation Brands, as applicable, hereby sell, convey, assign, transfer and deliver unto Buyer and its successors and assigns, all of their respective rights, title and interest in and to the Intellectual Property, including, without limitation, the trademark registrations and applications set out on Exhibit A-3 of the Agreement and as identified in Exhibit A attached hereto (the "Trademarks"), and including all rights to sue for past, present and future infringement thereof, together with the goodwill of the business connected with such Intellectual Property and symbolized by the Trademarks.

THIS ASSIGNMENT is intended to implement the provisions of the Agreement and shall not be construed to enhance, extend or limit the rights or obligations of Seller or Buyer thereunder.

THIS ASSIGNMENT may be executed in any number of counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.


