

ASSIGNMENT OF TRADEMARKS

WHEREAS, GEISINGER COMMUNITY HEALTH SERVICES, a 501(c)(3) not-for-profit organization designed to conduct charitable, scientific and education activities for the citizens of the communities served by the various individual entities that collectively comprise the Geisinger Health System including the operation of a Medicare-certified home health agency and the provision of health care services in a patient's home or place of residence, ("Assignor") has used and is using in its business the trademark set forth in Schedule A attached hereto (the "Marks");

Assignor hereby agrees to execute and deliver at the request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts that Assignee may require in order to vest all of Assignor's right, title and interest in and to the Marks in Assignee and/or provide evidence to support any of the foregoing in the event that such evidence is deemed necessary by Assignee.
