TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "Trademark Security Agreement") is made this 17th day of January, 2008, among the Loan Parties listed on the signature pages hereof (collectively, jointly and severally, "Loan Parties" and each individually "Loan Party"), and Wachovia Bank, National Association, a national banking association (together with its successors, "Secured Party").

WITNESSETH:

WHEREAS, pursuant to that certain Loan and Security Agreement of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement") among Raritan Americas, Inc., as borrower ("Borrower"), Raritan, Inc. and RIIP, Inc. as obligors, and Secured Party, Secured Party is willing to make certain financial accommodations available to Borrower pursuant to the terms and conditions thereof; and

WHEREAS, pursuant to the Loan Agreement, Loan Parties are required to execute and deliver to Secured Party this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Loan Party hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Loan Agreement.
2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Each Loan Party hereby unconditionally grants, assigns and pledges to Secured Party, a security interest in all of such Loan Party's right, title and interest in and to the following, whether now owned or hereafter acquired or arising and wherever located (collectively, the "Trademark Collateral"):
 - (a) all of its Trademarks including those referred to on Schedule I hereto; and
 - (b) all proceeds of the foregoing.
3. SECURITY FOR OBLIGATIONS. This Trademark Security Agreement and the security interest created hereby secures the payment and performance of the Obligations, whether now existing or arising hereafter. Without limiting the generality of the foregoing, this Trademark Security Agreement secures the payment of all amounts which constitute part of the Obligations and would be owed by Loan Parties, or any of them, to Secured Party, but for the fact that they are unenforceable or not allowable due to the existence of an insolvency, bankruptcy or similar proceeding involving any Loan Party.
4. SECURITY AGREEMENT. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to Secured Party pursuant to the Loan Agreement. Each Loan Party hereby acknowledges and affirms that the rights and remedies of Secured Party with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. To the extent there is any inconsistency between this Trademark Security Agreement and the Loan Agreement, the Loan Agreement shall control.
5. AUTHORIZATION TO SUPPLEMENT. If any Loan Party is granted or acquires or shall otherwise obtain rights to any new trademarks, the provisions of this Trademark Security Agreement shall automatically apply thereto. Loan Parties shall give prompt (and in any event within thirty (30) days) notice in writing to Secured Party with respect to any such new registered trademarks or trademark applications. Without limiting Secured Parties' obligations under this Section 5, Loan Parties hereby authorize Secured

Party unilaterally to modify this Agreement by amending Schedule I to include any such new trademark rights of Loan Parties. Notwithstanding the foregoing, no failure to so modify this Trademark Security Agreement or amend Schedule I shall in any way affect, invalidate or detract from Secured Party's continuing security interest in all Collateral, whether or not listed on Schedule I.

6. TERMINATION AND RELEASE. Upon indefeasible payment in full of the Obligations in accordance with the provisions of the Loan Agreement and the termination of the Loan Agreement, the security interest granted hereby shall automatically terminate and all rights to the Trademark Collateral shall immediately and irrevocably revert to Loan Parties or any other Person entitled thereto. At such time, Secured Party shall execute and deliver, and authorize the filing of, appropriate termination and release statements or other documents to terminate and release such security interests.

7. COUNTERPARTS. This Trademark Security Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. In proving this Trademark Security Agreement or any other Financing Agreement in any judicial proceedings, it shall not be necessary to produce or account for more than one such counterpart signed by the party against whom such enforcement is sought. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.

8. CONSTRUCTION. Unless the context of this Trademark Security Agreement or any other Financing Agreement clearly requires otherwise, references to the plural include the singular, references to the singular include the plural, the terms "includes" and "including" are not limiting, and the term "or" has, except where otherwise indicated, the inclusive meaning represented by the phrase "and/or." The words "hereof," "herein," "hereby," "hereunder," and similar terms in this Trademark Security Agreement or any other Financing Agreement refer to this Trademark Security Agreement or such other Financing Agreement, as the case may be, as a whole and not to any particular provision of this Trademark Security Agreement or such other Financing Agreement, as the case may be. Section, subsection, clause, schedule, and exhibit references herein are to this Trademark Security Agreement unless otherwise specified. Any reference in this Trademark Security Agreement or in any other Financing Agreement to any agreement, instrument, or document shall include all alterations, amendments, changes, extensions, modifications, renewals, replacements, substitutions, joinders, and supplements, thereto and thereof, as applicable (subject to any restrictions on such alterations, amendments, changes, extensions, modifications, renewals, replacements, substitutions, joinders, and supplements set forth herein or in the other Financing Agreement). Any reference herein or in any other Financing Agreement to the satisfaction or repayment in full of the Obligations shall mean the indefeasible repayment in full or cash collateralization, as applicable, in accordance with the terms thereof of all Obligations other than unasserted contingent indemnification Obligations. Any reference herein to any Person shall be construed to include such Person's successors and assigns.

9. GOVERNING LAW. The validity, interpretation and enforcement of this Trademark Security Agreement and the other Financing Agreements (except as otherwise provided therein) and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by the internal laws of the State of New York but excluding any principles of conflicts of law or other rule of law that would cause the application of the law of any jurisdiction other than the laws of the State of New York.
