RELEASE OF SECURITY INTEREST

This Release of a Security Interest ("Release") is made this 29<sup>th</sup> day of February 2008, by Bank of America, N.A., as administrative agent and collateral agent ("Administrative Agent") for the Secured Parties.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Administrative Agent hereby releases and remits to each Grantor any and all right, title and interest in and to the Collateral, including without limitation to the Trademarks and Copyrights identified in Schedules A and B, and hereby authorizes the Grantors' authorized representatives to (i) record this Release with the United States Patent and Trademark Office and (ii) file UCC-3 termination statements with the applicable filing office in connection with all UCC-1 financing statements filed by the Administrative Agent against the Grantors.
