(Subsidiary into parent pursuant to Section 253 of the General Corporation Law of Delaware)

Baxter County Newspapers, Inc., a corporation incorporated on the 24th day of August, 1970 pursuant to the provisions of the Arkansas Code (the "Parent"), the provisions of which permit the merger of a subsidiary corporation into a parent corporation organized and existing under the laws of said state, hereby certifies as follows:

1. The Parent owns 100% of the outstanding shares of capital stock of Media West - BCN, Inc., a corporation incorporated on the 23rd day of December, 1997 pursuant to the provisions of the General Corporation Law of the State of Delaware (the "Subsidiary").
2. On October 18, 2007, the Board of Directors of the Parent, acting by written consent in lieu of a meeting, approved the merger of the Subsidiary into the Parent and adopted the resolutions attached to this Certificate of Ownership and Merger as Exhibit A.
3. The Parent will be the surviving corporation in the merger.
4. The Parent agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of the Subsidiary as well as for enforcement of any obligation of the Subsidiary arising from the merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the Delaware General Corporation Law, and irrevocably appoints the Secretary of State of Delaware as its agent to accept service of process in any such suit or other proceeding. The address to which a copy of such process shall be mailed by the Secretary of State of Delaware is: Baxter County Newspapers, Inc., c/o Gannett Co., Inc., 7950 Jones Branch Drive, McLean, VA 22107, Attention: General Counsel.

WHEREAS, Baxter County Newspapers owns all of the issued and outstanding capital stock of Media West – BCN, Inc., a Delaware corporation ("BCN"); and

WHEREAS, the Board desires to merge BCN with and into Baxter County Newspapers.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to Section 4-27-1104 of the Arkansas Code, BCN will merge with and into Baxter County Newspapers (the "**Baxter County Newspapers Merger**") in accordance with the Plan of Merger attached hereto (the "**Baxter County Newspapers Plan of Merger**");

RESOLVED FURTHER, that the Board hereby authorizes, adopts and approves the Baxter County Newspapers Plan of Merger, including any exhibits thereto, and any and all other agreements referred to therein or contemplated thereby and required to be executed by and on behalf of Baxter County Newspapers in connection therewith, and all the transactions described therein and contemplated thereunder, including, without limitation, the Baxter County Newspapers Merger;

RESOLVED FURTHER, that the Baxter County Newspapers Merger shall be effective upon the making of the appropriate filing(s) or at such other time as may be determined by the officers of Baxter County Newspapers;

RESOLVED FURTHER, that any officer of Baxter County Newspapers be, and hereby is, authorized to do any and all acts on behalf of Baxter County Newspapers, including signing documents and causing them to be filed in the appropriate state and county offices, which such officer may deem necessary or advisable to carry out the purpose and intentions of the foregoing resolutions and to effectuate the Baxter County Newspapers Merger; and

RESOLVED FURTHER, that all actions taken and all agreements, instruments, reports, documents and regulatory and other notices executed, delivered or filed through the date hereof, and all actions to be taken and all agreements, instruments, reports, documents and regulatory and other notices to be executed, delivered or filed after the date hereof, by the authorized officers of Baxter County Newspapers, or any agents, attorneys, accountants and outside consultants of Baxter County Newspapers in connection with or with respect to effectuating all or any of the foregoing resolutions hereby are authorized, approved, ratified and confirmed in all respects.

PLAN OF MERGER
OF
MEDIA WEST - BCN, INC.
WITH AND INTO
BAXTER COUNTY NEWSPAPERS, INC.

THIS PLAN OF MERGER was approved by the board of directors of Baxter County Newspapers, Inc. pursuant to Section 4-27-1104 of the Arkansas Code and Section 253 of the Delaware General Corporation Law:

1. The name of the subsidiary corporation is Media West - BCN, Inc., a Delaware corporation.
2. The name of the parent corporation is Baxter County Newspapers, Inc., a Arkansas corporation.
3. Baxter County Newspapers, Inc. owns one hundred percent (100%) of the issued and outstanding shares of each class of capital stock of Media West - BCN, Inc.
4. The subsidiary corporation, Media West - BCN, Inc. (the "**Merging Corporation**"), shall merge with and into the parent corporation, Baxter County Newspapers, Inc. (the "**Surviving Corporation**"), with Baxter County Newspapers, Inc. surviving the merger.
5. The manner and basis of converting the shares of the Merging Corporation are as follows:
 - (a) No cash or other consideration shall be paid or delivered for shares of the Merging Corporation.
 - (b) The shares of the Merging Corporation shall not be converted into cash, securities or other obligations of the Surviving Corporation, but shall be surrendered and cancelled.
 - (c) All the issued and outstanding shares of the Surviving Corporation shall remain unchanged in the hands of the holder thereof as issued and outstanding shares of the Surviving Corporation.
 - (d) The Surviving Corporation shall assume all obligations of the Merging Corporation and upon the effectiveness of the merger, all property, rights, privileges, franchises, patents, trademarks, licenses, registrations and other assets of every kind and description of the Merging Corporation shall be transferred to and vested in the Surviving Corporation without any further act or deed.
