TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 26, 2008, is made by Bank of America, N.A. (formerly NationsBank, N.A.), as Collateral Agent (the "Secured Party").
