RELEASE AND TERMINATION AGREEMENT

This RELEASE AND TERMINATION AGREEMENT (the "**Agreement**") is made as of February ___, 2008, by WELLS FARGO BANK, NATIONAL ASSOCIATION, F/K/A NORWEST BUSINESS CREDIT, INC., with a principal place of business at 300 Commercial Street, Boston, MA 02109 (the "**Lender**") in favor of ANNALEE MOBILITEE DOLLS, INC., a New Hampshire corporation with a principal place of business at 50 Reservoir Road, P.O. Box 708, Meredith, NH 03253-0708 (the "**Borrower**").

Preliminary Statements:

WHEREAS, pursuant to the term and conditions of that certain Security Agreement, dated as of April 23, 1998 (as the same may have been amended, restated, supplemented or modified, from time to time, the "**Security Agreement**"), the Borrower granted to the Lender a security interest in, among other things, all of the rights, title and interests of the Borrower in and to (a) the trademarks and service marks described and listed in **Schedule A** attached hereto, (b) the patents described and listed in **Schedule B** attached hereto, and the copyrights described and listed in **Schedule C** attached hereto, (collectively, the "**Collateral**") in order to secure all indebtedness, obligations and liabilities of the Borrower to the Lender, whether now existing or hereafter arising (collectively, the "**Secured Obligations**"); and

WHEREAS, in consideration of the full payment by the Borrower of the Secured Obligations, the Lender now wishes to release, terminate and discharge its security interest and lien on the Collateral;

NOW, THEREFORE, in consideration of the full payment of the Secured Obligations, and in consideration of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby releases, terminates and discharges any and all of its security interests and liens on the Collateral.




