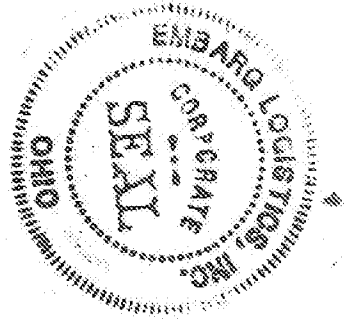

The Corporation existed as a direct, wholly-owned subsidiary of Sprint Nextel Corporation until May 17, 2006, on or about which date (a) 100% of the stock of Embarq Logistics, Inc. was transferred by Sprint Nextel Corporation to Embarq Corporation, a Delaware corporation and then a direct, wholly-owned subsidiary of Sprint Nextel Corporation; and (b) 100% of the stock of Embarq Corporation was distributed to the shareholders of Sprint Nextel Corporation. 4. The Corporation continues to exist as an indirect, wholly-owned subsidiary of Embarq Corporation (NYSE: EQ, FEIN 20-2923630), retaining its same Federal Employer Identification Number (34-1019982)
