TERMINATION OF SECURITY INTEREST



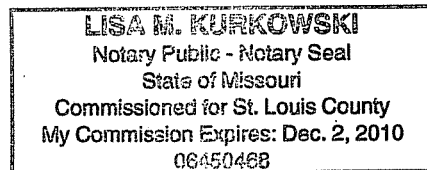
