**CERTIFICATE OF FIRST AMENDMENT TO THE  
 AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF  
 CALL COMMAND INC.**

(Pursuant to Section 242 of the General Corporation Law of the State of Delaware)

Call Command Inc., a corporation duly organized and existing under the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify that:

1. The name of the Corporation is Call Command Inc.
2. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on June 23, 2006.
3. The Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on July 6, 2006.
4. This First Amendment to the Amended and Restated Certificate of Incorporation amends the provisions of the Amended and Restated Certificate of Incorporation of the Corporation described below, but does not amend, alter, or otherwise modify the provisions of the Amended and Restated Certificate of Incorporation of the Corporation to the extent not addressed herein.
5. At a meeting of the Board of Directors of Call Command Inc., resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling a meeting of the stockholders of said corporation for consideration thereof.
6. Pursuant to resolution by the Board of Directors, a special meeting of the stockholders of said corporation was duly called and the following amendment was duly adopted in accordance with the provisions of Sections 242 and 228 (by written consent of the stockholders of the Corporation) of the General Corporation Law of the State of Delaware.
7. The Amended and Restated Certificate of Incorporation of the Corporation is hereby amended by deleting the FIRST Article thereof and inserting the following in lieu thereof:

**FIRST:** The name of this corporation is OneCommand, Inc. (the "Corporation").
