NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to (i) that certain Trademark Security Agreement, dated as of July 9, 2004 (the "*Initial Trademark Security Agreement*"), by Charles of the Ritz Group, Ltd. (the "*Grantor*") in favor of Citicorp USA, Inc., as Collateral Agent (the "*Collateral Agent*"), recorded in the United States Patent and Trademark Office at Reel 002891, Frame 0913, and (ii) that certain Trademark Security Agreement, dated as of December 20, 2006 (the "*Amended and Restated Trademark Security Agreement*" and, together with the Initial Trademark Security Agreement, the "*Trademark Security Agreements*"), by the Grantor in favor of the Collateral Agent, recorded in the United States Patent and Trademark Office at Reel 003453, Frame 0255, the Grantor assigned and granted to the Collateral Agent a security interest in the Grantor's right, title and interest in and to the Trademarks listed on Exhibit A hereto (the "*Released Assets*"); and

WHEREAS, the Collateral Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Assets;

NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee does hereby agree as follows:

1. Release. The Collateral Agent hereby relinquishes, releases and discharges its security interest in the Released Assets.
2. Further Assurances. The Collateral Agent hereby agrees, at the Grantor's expense, to execute such instruments and to take such other actions as the Grantor may reasonably request to terminate the Collateral Agent's security interest in the Released Assets.
3. Governing Law. This Notice of Release of Security Interest in Trademarks shall be governed by and construed and interpreted in accordance with the laws of the State of New York.
4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Trademark Security Agreements.
