ASSIGNMENT OF TRADEMARKS

The Assignor undertakes at the request and expense of the Assignee to do all acts and execute all documents which may be reasonably necessary to effect or perfect the assignment of the Marks to Assignee or confirm the title of the Assignee to the Marks assigned, whether in connection with any registration of such title or otherwise.

The provisions of this assignment shall not limit the full force and effect of the terms and provisions of the Purchase Agreement, and that in the event of a conflict between the terms and provisions of this assignment and the terms and provisions of the Purchase Agreement, the terms and provisions of the Purchase Agreement shall prevail, govern and control in all respects without limitation. This assignment shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York, without giving effect to the principles of conflict of laws thereof (except any provisions of the laws of such State that would render such choice of law ineffective).
