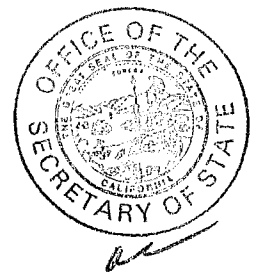
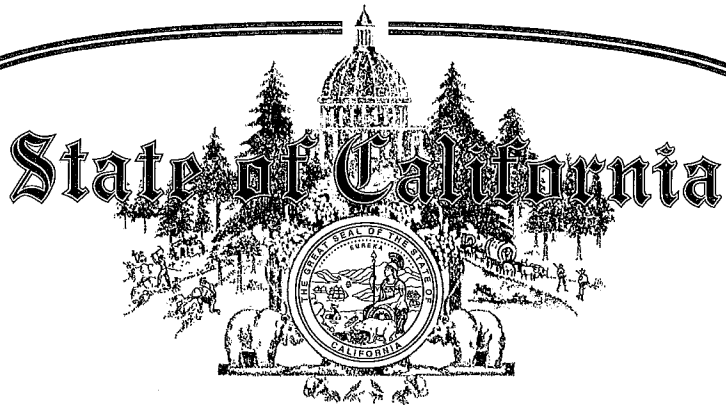

RESTATED ARTICLES OF INCORPORATION

The undersigned certify that:

1. They are the president and secretary, respectively, of L.I.F.E. Bible College, Inc, a California corporation.
2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

ARTICLE ONE

The name of this corporation is LIFE PACIFIC COLLEGE.

ARTICLE TWO

This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law exclusively for religious purposes. This corporation elects to be governed by all of the provisions of the Nonprofit Corporation Law of 1980 not otherwise applicable to it under Part 5. The specific purpose of this corporation is to establish, maintain and operate an institution of higher education for the International Church of the Foursquare Gospel.

ARTICLE THREE

This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax as an organization described in section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code.) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

ARTICLE FOUR

The property of this corporation is irrevocably dedicated to religious purposes

and no part of the net income or assets of this corporation shall ever inure to the benefit of any director or officer thereof or to the benefit of any private person. Upon the dissolution or winding up of this corporation, all assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code.)

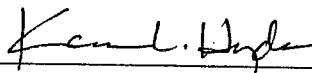
3. The foregoing amendment and restatement of Aricles of Incorporation has been duly approved by the board of directors.

4. The corporation has no members.
