CERTIFICATE OF MERGER

Pursuant to the provisions of Section 252(c) of the Delaware General Corporation Law (the "DGCL"), the undersigned corporation submits the following Certificate of Merger for the purpose of effecting a merger under the DGCL.

1. The name and state of incorporation of each of the constituent corporations is as follows:

The surviving corporation agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of any constituent corporation of the State of Delaware, as well as for enforcement of any obligation of the surviving corporation arising from the merger, including any suit or other proceeding to enforce the right of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the DGCL. The surviving corporation irrevocably appoints the Secretary of State as its agent to accept service of process in any such suit or other proceedings, and a copy of such process shall be mailed by the Secretary of State to the surviving corporation c/o Neill P. Davis, The Men's Wearhouse, Inc., 6380 Rogerdale, Houston, Texas 77072.

8. The merger shall become effective at 11:59 p.m., Eastern time, on December 31, 2007.
