TRADEMARK ASSIGNMENT

WHEREAS, WindsorTech, Inc., a corporation of the State of Delaware (hereinafter "Assignor"), having an address at 70 Lake Drive, Hightstown, New Jersey 08520, being the lawful owner of the Trademarks identified in Exhibit A, attached hereto and incorporated by reference herein, and including any and all common law trademarks, registered trademarks and trademark applications claiming priority to the Trademarks identified in Exhibit A;

WHEREAS, QSGI, Inc., a corporation of the State of Delaware (hereinafter "Assignee"), having an address at 70 Lake Drive, Hightstown, New Jersey 08520 is desirous of acquiring the entire right, title and interest in and to said Trademarks;

NOW, THEREFORE, in consideration of the sum of ten dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor, by these presents do sell, assign and transfer unto Assignee, its successors and assigns, the full and exclusive right, title and interest to the Trademarks in Exhibit A, and together with the goodwill symbolized by the Trademarks, and all registrations, applications and/or common law trademarks and uses thereof and renewals and extensions of the foregoing in the United States and for all foreign countries that are or may be secured under the laws of the United States, together with all income, royalties, payments due or payable to Assignor, or rights to damages for the Trademarks or the goodwill associated with the Trademarks identified in Exhibit A as of the effective date of this Assignment or thereafter, including, without limitation, any and all claims for damages by reason of past, present, or future infringement or other unauthorized use of the trademarks, with the right to sue for and collect the same for the use and benefit of Assignee and its successors and assigns.

Assignor warrants that it is the exclusive owner of the entire legal and equitable interest in the Trademarks disclosed therein, free and clear of all liens and encumbrances; and that it has full power, authority, and capacity to make this Assignment to Assignee. Assignor authorizes the Commissioner of Patents and Trademarks of the United States and any official of any state or country foreign to the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of the Assignee, its successors, legal representatives and assigns in accordance with the terms of this instrument. Assignor further covenants and agrees for himself and for his successors and assigns that, at Assignee's request, Assignor will cause to be executed and delivered any applications, affidavits, assignments, and other instruments as may be deemed necessary or desirable by Assignee to secure for or vest in Assignee, its successors or assigns, all right, title, and interest in and to any application, trademark, or other right or property covered by this assignment, including the right to apply for and obtain trademarks in foreign countries under the provisions of the International Convention; and Assignor hereby requests and authorizes the United States Commissioner of Patents and Trademarks to issue any and all United States trademark registrations granted on the Trademarks to Assignee as owner of the entire right, title, and interest in and to the same, and authorizes appropriately empowered officials of foreign countries to issue any trademark registrations granted on the Trademarks to Assignee as owner of the entire right, title, and interest in and to the same.
