RELEASE OF LIEN ON TRADEMARKS

WHEREAS, pursuant to a certain Trademark Security Agreement, dated as of December 15, 2004 (as amended, restated or otherwise modified, the "Agreement") between Russ Berrie and Company, Inc. , Kids Line, LLC and Sassy, Inc. ("Assignors") and California KL Holdings, Inc., in its capacity as collateral agent ("Assignee"), which Agreement was recorded with the United States Patent and Trademark Office on December 22, 2004, on reel 2996 frame 0457, Assignors granted to the Assignee a security interest in and lien on all of the Assignors' right, title and interest in, to (i) all of its trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks and service mark applications (collectively, the "Trademarks") including those referred to on Schedule I hereto and trademark licenses to which it is a party, (ii) all reissues, continuations or extensions of the foregoing, (iii) all goodwill of the business connected with the use of, and symbolized by, each trademark and each intellectual property license, and (iv) all products and proceeds of the foregoing, including, without limitation, any claim by the Assignors against third parties for past, present or future (a) infringement or dilution of any trademark or any trademark licensed under any intellectual property license or (b) injury to the goodwill associated with any trademark or any trademark licensed under any intellectual property license (all of the foregoing, collectively, the "Trademark Collateral").

WHEREAS, the Assignee desires to release its security interest in and lien on the Trademark Collateral including the Trademarks set forth on Schedule I attached hereto; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee does hereby release its security interest in and lien on the Trademark Collateral including the Trademarks set forth on Schedule I attached hereto, and reassigns to Assignors all right, title and interest of the Assignee in and to such Trademark Collateral.
