RELEASE OF SECURITY

WHEREAS Berkeley Systems, Inc. (a California Corporation) was reformed as a Delaware Corporation under the name Berkeley Systems Incorporated [recorded in the United States Patent and Trademark Office ("USPTO") under Assignment Reel/Frame 0902/0392]; and,

WHEREAS, Berkeley Systems Incorporated (a Delaware Corporation) was wholly acquired by and merged into Vivendi Universal Games, Inc. (a Delaware Corporation) [recorded in the USPTO under Assignment Reel/Frame 3540/0482]; and,

WHEREAS Vivendi Universal Games, Inc. changed its name to Vivendi Games, Inc. [recorded in the USPTO under Assignment Reel/Frame 3540/0849]; and,

WHEREAS Vivendi Games, Inc. (a Delaware Corporation) [*the Company*] is the rightful owner of record for the federally registered trademarks described in the attached **Schedule A** [*the Trademarks*] for which there are corresponding entries in the USPTO under the numbers set forth in the said attached Schedule; and,

WHEREAS pursuant to the security agreement [*the Trademark Assignment*] Berkeley Systems, Incorporated granted a security interest in (but not limited to) *the Trademarks* to CUC INTERNATIONAL, INC. (a Delaware corporation) to secure the payment and performance by Berkeley Systems, Incorporated of certain of its obligations [recorded in the USPTO under Assignment Reel/Frame 1575/0899]; and,

WHEREAS *the Trademark Assignment* was received in the Assignment Branch of the United States Patent and Trademark Office on April 3, 1997 located at Reel/Frame: 1575/0899;

WHEREAS, *the Company* is the successor in obligation to the *Trademark Assignment*; and,

WHEREAS CUC INTERNATIONAL, INC. entered into a merger with HFS INCORPORATED (a Delaware Corporation) on December 19, 1997 with the surviving corporation thereupon changing its name to CENDANT CORPORATION (a Delaware corporation);

WHEREAS CENDANT CORPORATION changed its name to AVIS BUDGET GROUP, INC. on August 26, 2006, and is the successor in interest to the obligations codified in *the Trademark Assignment*;

NOW, THEREFORE, for good and valuable consideration receipt of which is hereby acknowledged, and effective as of the date of signature, the undersigned does hereby affirmatively relinquish and terminate any and all of its security interests in *the Trademarks* including (a) all income, royalties, damages and payments now and hereafter due and/or payable under with respect thereto, (b) all payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all of *the Company's* rights corresponding thereto throughout the world.
