**FIFTH:** The authorized stock and par value of the non-Delaware corporation is cancelled.

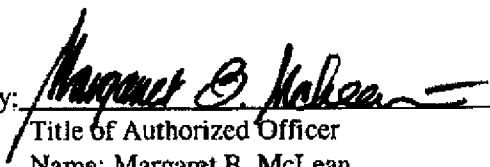
**SIXTH:** The merger is to become effective on December 17<sup>th</sup>, 2007.
