QUIT CLAIM OF TRADEMARK

WHEREAS, SKOR SPORTS, INC., a Hawaiian corporation, with its business address at P.O. Box 240333, Honolulu, HI 96824, is desirous of obtaining clear, unclouded and un-restricted title to the trademark, TURBO SURF DESIGNS HAWAII & Design, whether registered, pending, common-law or otherwise and all right, title and interest thereto; which trademark has been registered with the United States Patent & Trademark office as Registration Number 1,436,535;

AND WHEREAS, SKOR SPORTS, INC. was assigned all right title and interest in and to such trademark by TURBO SURF DESIGNS HAWAII, INC., a Hawaii corporation on June 22, 1998 and recorded such assignment with the U.S. Patent & Trademark Office on June 28, 2001 at Reel & Frame: 2321/457;

AND WHEREAS, WHAM-O, INC. , a Delaware corporation, with offices at 5903 Christie Ave, Emeryville CA 94608, did inadvertently include such trademark registration in a list of collateral pledged for a loan from Congress Financial Corp. and such security interest was recorded with the U.S. Patent & Trademark Office on January 23, 2001 at Reel & Frame: 2218/475;

AND WHEREAS, CONGRESS FINANCIAL CORP. tried to remove said trademark from the collateral held by CONGRESS FINANCIAL CORP. by filing a RELEASE AND REASSIGNMENT with the U.S. Patent & Trademark Office on April 10, 2002 at Reel & Frame 2479/443;

AND WHEREAS, WACHOVIA CAPITAL FINANCE CORP., formerly CONGRESS FINANCIAL CORP. purported again to release such inadvertently pledged security interest in such trademark by a "RELEASE OF SECURITY INTEREST IN TRADEMARKS," to WHAM-O, INC. recorded with the U.S. Patent & Trademark Office on June 15, 2005 at Reel & Frame: 3112/721;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, WHAM-O INC., hereby quit claims, assigns and transfers to SKOR SPORTS, INC. any right, title and interest it may own in said trademark whether such interest be vested, executory, future or contingent, in the United States, in and to said trademark, together with the goodwill of the business symbolized by said trademark and registration. WHAM-O INC. makes no warranty or representation that it has any interest in or to said trademark or registration or that it ever had any interest in said trademark or registration. SKOR SPORTS, INC. on behalf of itself, its affiliates and all of its predecessors and successors in interest, specifically releases, waives, and forever discharges WHAM-O INC. and its successors in interest, past, present and future assigns, officers, directors, subsidiaries, affiliates, licensees, insurers and underwriters, from any and all claims, demands, actions, liabilities and causes of actions related to said trademark and registration, whether asserted or unasserted, whether known or unknown, suspected or unsuspected, in law or in equity.
