Assignment Nunc Pro Tunc

WHEREAS, Marksmen, LLC ("Assignor"), a Nevada limited liability company formed on December 10, 1997 with its principal offices at 116 North Maryland Avenue, Glendale, California 91206, adopted and used the trademarks shown on the attached Schedule A (the "Marks"), and obtained and owned the corresponding registrations for the Marks as listed on Schedule A;

WHEREAS, on April 17, 2000, the principals of Assignor created a related entity named Marksmen, Inc. ("Assignee"), a Delaware corporation also having its offices at 116 North Maryland Avenue, Glendale, California 91206;

WHEREAS, in 2001, Assignor informally merged its assets into Marksmen, Inc. ("Assignee"), and as part of such transaction conveyed to Assignee the Marks, all rights thereto, and all business and goodwill associated with the Marks, after which Assignee carried on the business of Assignor as a going concern;

WHEREAS, the conveyance of the Marks to Assignee was not memorialized in writing;

WHEREAS, Assignor ceased to exist as a corporate entity on January 1, 2007; and,

WHEREAS, Ken Taylor served as the President of Assignor throughout its existence, and has served as the President of Assignee from its incorporation to the present.

NOW THEREFORE, as Assignor conveyed the Marks to Assignee in 2001 and Assignee is the successor to Assignor, this nunc pro tunc assignment is being executed now in order to clarify the ownership of the Marks, and to confirm that Assignor did assign unto Assignee all rights, title and interest in and to the Marks, together with the goodwill of the business symbolized by the marks.
