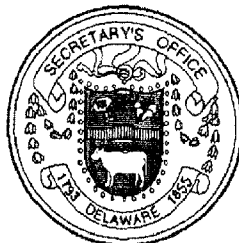

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of the Corporation adopted a resolution by the unanimous written consent of its members, filed with the minutes of the Corporation, proposing and declaring advisable the following amendment to the Corporation's Amended and Restated Certificate of Incorporation:
