NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. releases and reassigns to WGI any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreements in the trademarks more fully described on **Exhibit A**, without recourse or representation or warranty, express or implied; and
