**U.S. PATENTS AND TRADEMARKS RELEASE OF SECURITY INTEREST**

THIS PATENT AND TRADEMARK RELEASE dated as of March 7, 2008, between INVISTA North America S.à.r.l., a Luxembourg limited liability company ("*INVISTA NA*") and JPMORGAN CHASE BANK, N.A. ("*JPMorgan*"), as administrative agent (in such capacity, the "*Administrative Agent*"). Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or Collateral Agreement, as applicable, referred to below.

A. Reference is made to the Credit Agreement, dated as of April 30, 2004, as amended and restated as of January 16, 2006 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "*Credit Agreement*"), among INVISTA B.V. (formerly known as KoSa B.V.), INVISTA S.à.r.l. (formerly known as Arteva Specialities S.à.r.l.), INVISTA (Canada) Company (formerly known as KoSa Canada Company), KoSa UK Limited and Arteva Global Holdings B.V., the Lenders party thereto and the Administrative Agent.

B. Reference is made to the Guarantee and Collateral Agreement dated as of April 30, 2004 (as amended, restated, supplemented, reaffirmed or otherwise modified from time to time prior to the date hereof, the "*Collateral Agreement*") among the Guarantors, the Grantors and the Administrative Agent pursuant to which the IP Grantors (as defined in the Collateral Agreement) granted a security interest in favor of the Administrative Agent, for the benefit of the Secured Parties, in, among other things, certain registered Patents, Patent Applications and registered Trademarks of the IP Grantor.

C. Reference is made to (i) the Patent, Copyright and Trademark Security Agreement, dated as of April 30, 2004, (ii) the Patent, Copyright and Trademark Security Agreement, dated as of March 31, 2005, (iii) the Patent, Copyright and Trademark Security Agreement, dated as of April 17, 2006, (iv) the Patent, Copyright and Trademark Security Agreement, dated as of April 5, 2007, and (v) the Patent, Copyright and Trademark Security Agreement, dated as of December 7, 2007 (collectively, the "*IP Security Agreements*"), between INVISTA NA and the Administrative Agent pursuant to which INVISTA NA granted a security interest in favor of the Administrative Agent, for the benefit of the Secured Parties, in, among other things, certain registered patents, patent applications and registered trademarks of INVISTA NA, which security interest was recorded with the United States Patent & Trademark Office.

D. Reference is made to the Asset Purchase Agreement dated as of November 30, 2007 (the "*Asset Purchase Agreement*"), among INVISTA S.à.r.l., Servicios Corporativos Arteva, S. de R.L. de C.V., Arteva Specialities, S. de R.L. de C.V., Arteva Polycom, S. de R.L. de C.V., INVISTA B.V. (collectively, the "*Sellers*"), INA Fibers Holding Corp. and Performance Fibers Holdings, Inc.

E. In connection with the consummation of the sale pursuant to the Asset Purchase Agreement, INVISTA B.V. and INVISTA NA have informed the Administrative Agent of their desire to record the release of all right, title and interest of the Administrative Agent and the other Secured Parties in and to solely the Patents and Patent Applications on set forth on Schedule I hereto (the "*Patents*") and in and to solely the Trademarks set forth on Schedule II hereto (the "*Trademarks*").


F. Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby releases its security interests in and to the Patents, Patent Applications and Trademarks that were granted pursuant to the IP Security Agreements, and such security interests shall automatically terminate as provided in the Collateral Agreement and are hereby reassigned to INVISTA N.A. In connection with the release pursuant to this paragraph F, the Administrative Agent shall promptly execute and deliver to INVISTA N.A., at INVISTA N.A.'s expense, all documents that it shall reasonably request to evidence such release. Any execution and delivery of documents, including this U.S. Patents and Trademarks Release of Security Interest, shall be without recourse to or warranty by the Administrative Agent.


