AMENDMENT TO TRADEMARK COLLATERAL ASSIGNMENT

The Trademark Collateral Assignment ("Assignment") dated August 29, 1989, between BALCO, INC. (formerly Balco International, Inc.) ("Balco") or ("Assignor"), 2626 South Sheridan, Wichita, Kansas 67217, and MARINE MIDLAND BUSINESS LOANS, INC. ("Lender") 1101 Walnut Street, Kansas City, Missouri 64106 and recorded in the Patent and Trademark Office on January 19, 1990, on Reel 0690, Frame 469-475 and covering the United States Trademarks set forth on Schedule A hereto is hereby amended by mutual agreement of the parties as follows:

1. On the first page of the Assignment the first sentence of the second paragraph is hereby deleted and a new second paragraph substituted which reads as follows:

"Assignor has executed and delivered its Promissory Notes to the Lender in the aggregate principal amount of \$4,796,000.00 (the "Indebtedness") pursuant to an Amended and Restated Loan and Security Agreement dated August 13, 1991 (as amended from time to time, collectively the "Loan Agreement") between Assignor and Lender. In order to induce the Lender to execute and deliver the Loan Agreement, Assignor has agreed to assign to Lender certain Trademark rights as security for the payment of the Promissory Notes and future indebtedness."

2. All reference in the Assignment to the "Loan Agreement" shall be to the Amended and Restated Loan and Security Agreement dated August 13, 1991.

3. All reference in the Assignment to the term "Indebtedness" shall be to the Indebtedness as defined in the Amended and Restated Loan and Security Agreement.

4. All of the terms and conditions of the Trademark Collateral Assignment between the Assignor and the Lender dated August 29, 1989, shall remain in full force and effect except as herein amended.
