1. In consideration of the sum of 3 pounds (£3) sterling paid by the Assignee to the Assignor, the receipt of which the Assignor acknowledges, the Assignor for itself and its subsidiaries hereby:-
 - 1.1 assigns to the Assignee with full title guarantee the trade marks set out in Schedule II, including all rights connected with those trade marks and the right to sue for and obtain full and effective relief in respect of every act of infringement of such trade marks occurring prior to the date of this Assignment; and
 - 1.2 assigns such rights as it may have in the trade mark listed in Schedule I and (to the extent that such trade mark is not owned by the Assignor) undertakes to use reasonable endeavours to procure the assignment of such mark if the Assignor is legally entitled to do so at the date of this Agreement.
2. Notwithstanding any implied covenant of title, at the request of the Assignee and the sole cost of the Assignor, the Assignor shall or shall procure that its relevant subsidiary shall execute all such further documents, forms and authorisations and depose and swear any declaration or oath as may be required by the registry of trade marks of the relevant jurisdiction or which may, in the reasonable opinion of the Assignee, otherwise be necessary for absolutely vesting full right, title and interest in and to the trade marks set out in Schedules I and II in the Assignee.
3. In this Assignment, where the context so admits or requires, words denoting the singular include the plural and vice versa and words denoting any gender include all genders.
4. The construction, validity and performance of this Assignment shall be governed by the laws of England and the parties hereto submit to the exclusive jurisdiction of the English courts for the purpose of enforcing any claim hereunder.
