RESOLVED: That the Subsidiary be merged with and into the Corporation, and the Corporation assume all of Subsidiary's liabilities and obligations (the "Merger");

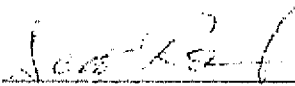
