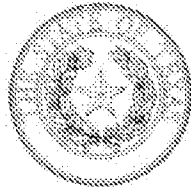

On August 6, 2001, the Office of the Texas Secretary of State converted to a new computer system. One of the many changes to procedure effected by the new system is the change to the look of the certificates of filing and certification of facts or copies by the Corporation Section.

Prior to our conversion, certificates issued by the Corporations Section were printed on special certificate paper that contained a pre-printed gold seal. Under our new system we are generating certificates using electronic signatures and black and white seals, and we are generating certificates over the WEB. Consequently, articles of incorporation, articles of organization, certificates of amendment, certificates of existence (certificates of status), and all other certificates issued by this office will no longer be on "gold-seal paper".

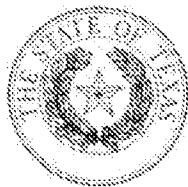

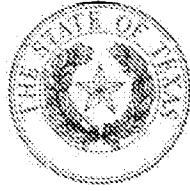

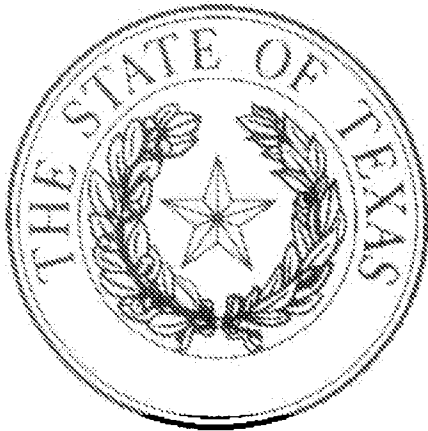

Pursuant to the provisions of the Texas Business Corporation Act, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Universal Compression, Inc. (the "Corporation").
2. The following Amendment to the Articles of Incorporation of the Corporation, deleting the first article thereof and replacing in lieu thereof a new first article, was adopted by the sole shareholder of the Corporation on the 20th day of August 2007:

"FIRST. The name of the corporation is Exterran, Inc."

3. The number of shares of the Corporation outstanding at the time of such adoption was 4,910 shares; and the number of shares entitled to vote thereon was 4,910 shares.
4. The number of shares voted for such amendment was 4,910 shares, and the number of shares voted against such amendment was 0.
