

Graziano Cerchiai and Diana Cerchiai hereby certifies that:

1. They are the President and Secretary, respectively, of Three Sixty Five Club, a California corporation.
2. Article I of the Articles of Incorporation of this corporation is amended to read as follows:
 " First: The name of the corporation is Bimbo's 365 Club, Inc."
3. Article 4 of the Articles of Incorporation is amended to read as follows:
 "Fourth: the total number of shares which the corporation is authorized to issue is Twenty Thousand (20,000) shares of common stock. The par value is One Dollar and Twenty Five Cents (\$1.25) per share"
4. The foregoing amendments of Articles of Incorporation have been duly approved by the Board of Directors.
5. The foregoing amendments of Articles of Incorporation have been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of Common Stock is 2,500 shares. The number of shares voting in favor of the Amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the outstanding shares of Common Stock.
