TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT, effective as of February 22, 2008 (the "Effective Date"), is by and between **Trans Union LLC**, a Delaware corporation ("TU" and "Assignor"), and **Trans Union Settlement Solutions, Inc.**, a Delaware corporation ("TUSSI" and "Assignee").

RECITALS

WHEREAS, TU is the owner of certain trademark registrations listed on Schedule A attached hereto (the "Trademarks");

WHEREAS, TUSI is entering into a Purchase Agreement with MacDonald, Dettwiler and Associates Corp. ("MacDonald"), whereby MacDonald is purchasing Equity Interests from TUSI ; and

WHEREAS, in preparation for the consummation of the transactions contemplated by the Purchase Agreement, TUSI desires to acquire, and TU has agreed to assign, the Trademarks and all rights associated therewith.

NOW, THEREFORE, in consideration of the foregoing, and in order to make and record a specific formal assignment of the Trademarks from Assignor to Assignee, and for good and valuable consideration, including consideration previously transferred, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. **ASSIGNMENT.** Assignor hereby assigns, transfers, and conveys to Assignee and its successors and assigns, all right, title and interest, throughout the world, in, to and under the Trademarks that Assignor may have, including without limitation: (i) registration numbers corresponding to the Trademarks, (ii) all common law rights in the Trademarks; (iii) any goodwill associated with and symbolized by the Trademarks; (iv) the right to further assign and/or to license any and all right, title and interest in the Trademarks; and (v) the right to sue and collect damages for past infringement of the Trademarks by any third party.

2. **DOCUMENTATION; COOPERATION.** Assignor does hereby covenant and agree, for itself and its successors and assigns, that it will execute and deliver to Assignee, any and all additional documents and perform any further acts necessary to vest in Assignee the rights hereby conveyed.

3. **RECORDATION.** Assignee agrees that it will prepare and submit all documents that may be required to effectuate recordation of this Trademark Assignment with the U.S. Patent and Trademark Office.
