2. The within assignment shall be deemed to be an assignment from Assignor to Assignee and as to such assignment, Assignee shall be deemed to be the successor in interest to that portion of the business of Assignor to which The Mark relates and Assignor shall otherwise remain in business.
3. The within assignment is made on an "AS IS" basis without any warranties since Assignee is fully aware of all the business matters of Assignor.
4. This document constitutes the complete and entire agreement and understanding of the parties hereto, and there are no other agreements, promises, representations or undertakings that supersede this agreement or adversely affect the assignment and transfers contemplated, made and/or given herein. The parties and each of them undertake and agree to prepare, provide and execute any and all documents as may be required by law to transfer, effectuate, and perfect the rights conveyed herein and hereby to Assignee and to enable the recordation of such transfers with all applicable governmental authorities to perfect the rights so transferred herein to Assignee.
