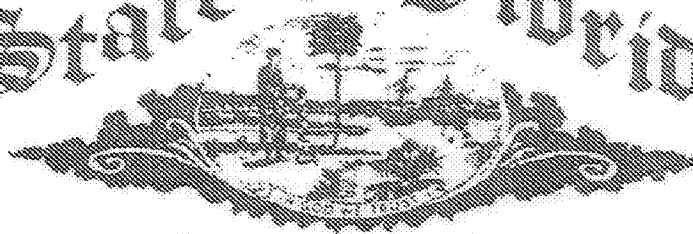

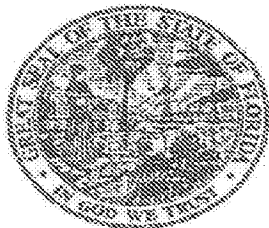

TO
ARTICLES OF ORGANIZATION
