RELEASE OF SECURITY INTERESTS
IN INTELLECTUAL PROPERTY

BOSCOV'S DEPARTMENT STORE, LLC, a Pennsylvania limited liability company, SDS. INC., a Pennsylvania corporation, BOSCOV'S, INC., a Pennsylvania corporation, BOSCOV'S PSI INC., a Pennsylvania corporation, BOSCOV'S INVESTMENT COMPANY, a Delaware corporation, BOSCOV'S FINANCE COMPANY, INC., a Delaware corporation and RETAIL CONSTRUCTION & DEVELOPMENT, INC., a Delaware (collectively the "Grantors"), executed an Intellectual Property Security Agreement dated as of January 27, 2006 in favor of BACK BAY CAPITAL FUNDING LLC., as collateral agent (the "Collateral Agent"), which Agreement was duly recorded on January 30, 2006 at (i) Reel/Frame 003236/0402 and (ii) Reel/Frame 017087/0429 in the United States Patent and Trademark Office pursuant to which the Grantors assigned and granted to the Collateral Agent a security interest (the "Security Interest") in and to all of the Grantors' right, title and interest in and to certain trademarks, patents, copyrights, trade secrets and licenses, including those specifically listed on Exhibit A attached hereto (the "Released Intellectual Property") and the goodwill associated therewith.


For good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent without recourse, representation or warranty and at the Grantors' sole cost and expense, hereby irrevocably releases, terminates and discharges the entirety of the Security Interest in the Released Intellectual Property and retransfers and reassigns to the Grantors, without representation or warranty of any kind, express or implied, all of the Collateral Agent's right, title and interest in and to the Released Intellectual Property and the good will associated therewith.

The Collateral Agent hereby agrees, at the Grantors' sole cost and expense, to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest in the Released Intellectual Property.
