INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, dated as of March 17, 2008, by and between Thomson TradeWeb LLC ("Assignor"), and TradeWeb Markets LLC ("Assignee").

Assignor hereby sells, assigns, conveys, and transfers to Assignee, for Assignee's sole and exclusive use and enjoyment, all of Assignor's right, title and interest in and to the Assigned Patents and the Assigned Trademarks, including all rights to sue and recover damages for past infringement thereof.
2. Recordation. Assignor hereby authorizes and requests that the Commissioner for Trademarks of the United States issue and record the title of Assignee as owner of all right, title, and interest in and to the Assigned Trademarks, and that the Commissioner for Patents of the United States issue and record the title of Assignee as owner of all right, title, and interest in and to the Assigned Patents.
3. Governing Law. This instrument shall be construed in accordance with and governed by the laws of the State of New York, without giving effect to the conflicts of law principles thereof.
4. Counterparts. This instrument may be executed by facsimile signature and in one or more counterparts, each of which shall for all purposes be deemed to be an original and all of which shall constitute the same instrument.
5. Headings. The headings contained in this instrument are for reference purposes only and shall not affect in any way the meaning or interpretation of this instrument.

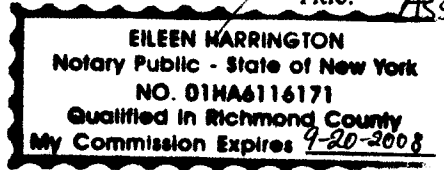
