## AGREEMENT AND PLAN OF DIVISION

ADOPTED as of July 1, 2001, by **HOME GARDENER MANUFACTURING COMPANY** ("the Existing Corporation"), a Pennsylvania corporation having its principal office and place of business at Wright Avenue, Lititz, Pennsylvania 17543.

### Background:

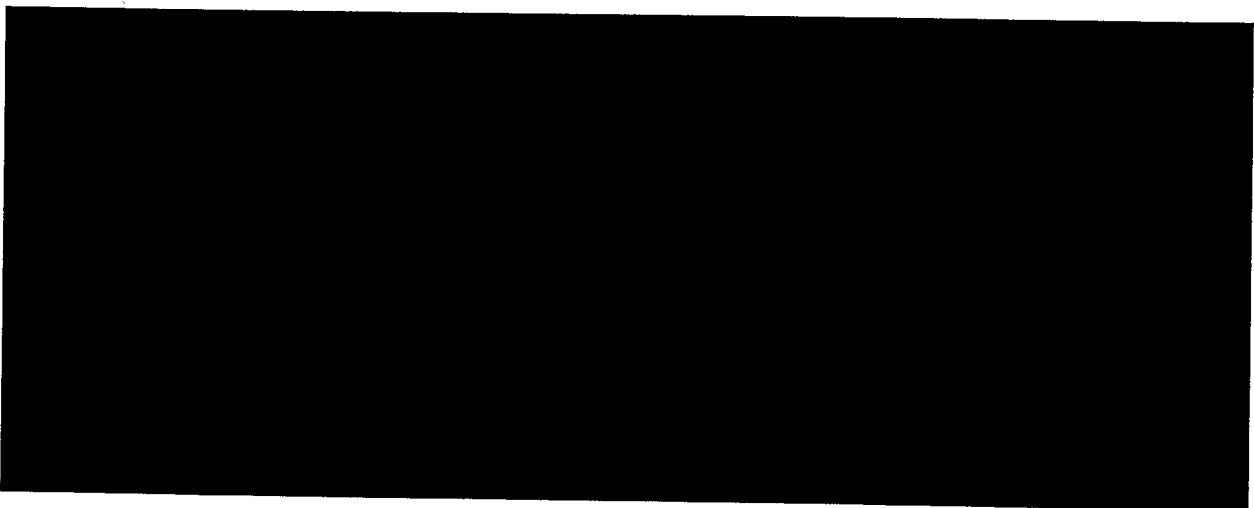
The shareholders of the Existing Corporation, have determined that it is in the best interests of the Existing Corporation to divide into two separate and distinct Pennsylvania business corporations, each owned in the same proportions by the existing shareholders.

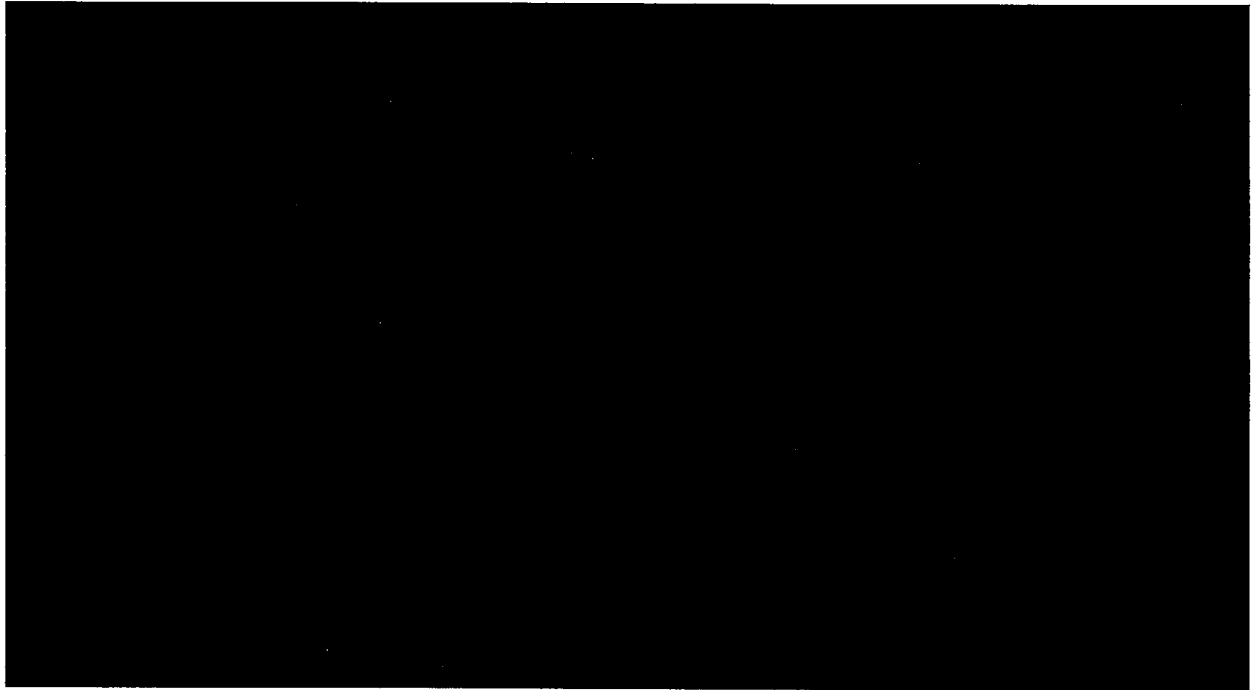
The Existing Corporation intends to divide into two corporations for that purpose and the parties have entered into this Agreement and Plan to set forth the terms and conditions of the division. The Existing Corporation has approved and adopted this Plan by the unanimous written consent of its Board of Directors and Shareholders, in accordance with Sections 1727(b), 1766(a), and 1952(c) of the Pennsylvania Business Corporation law of 1988.

NOW THEREFORE, Home Gardener Manufacturing Company adopts the following Plan of Division:


1. **Division.** Pursuant to Section 1951 of the Pennsylvania Business Corporation Law of 1988, the Dividing Corporation shall divide into (a) itself (hereinafter sometimes referred to as the "Existing Corporation") and (b) Finley Products, Inc., a Pennsylvania corporation ("the New Corporation"), subject to the terms and conditions of this Plan.

2. **Effective Date.** This Division shall become effective on July 1, 2001 by virtue of filing Articles of Division in the Department of State of the Commonwealth of Pennsylvania. The date of filing of articles is referred to herein as "the Effective Date".




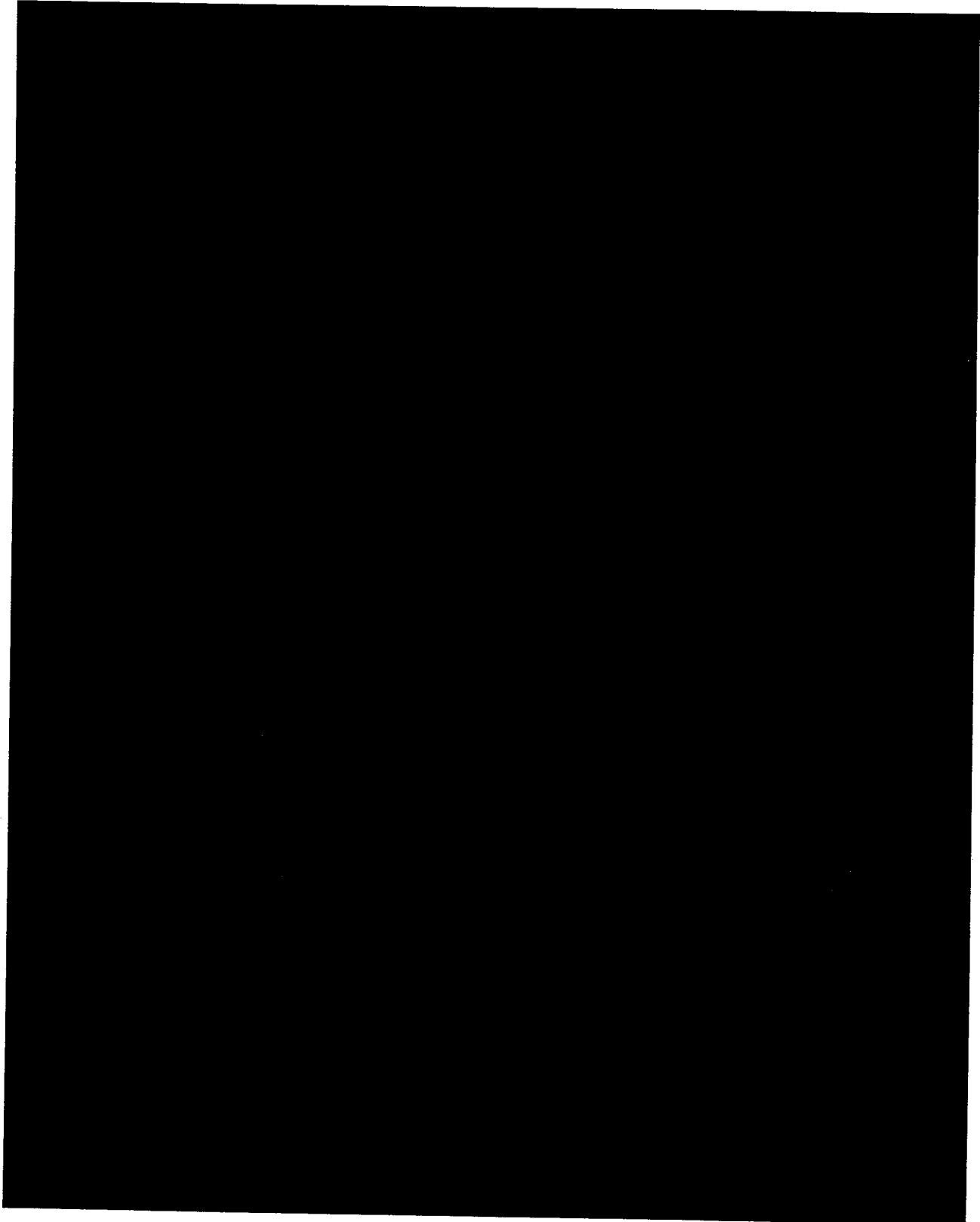


7. **Effect of Division.** On the Effective Date, the assets and liabilities of the Dividing Corporation shall be divided between the New Corporation and the Existing Corporation in the manner described in this Section 7. The assets and liabilities which are allocated to the Existing Corporation and the New Corporation on the Effective Date shall be reflected on the books of the Existing Corporation and the New Corporation as they appeared on the books of Existing Corporation immediately prior to the Division under this Plan of Division.



(b) The assets of the Existing Corporation that are set forth on Exhibit C, which is attached hereto and incorporated herein by reference, shall be allocated to and vested in the New Corporation without further act or deed.

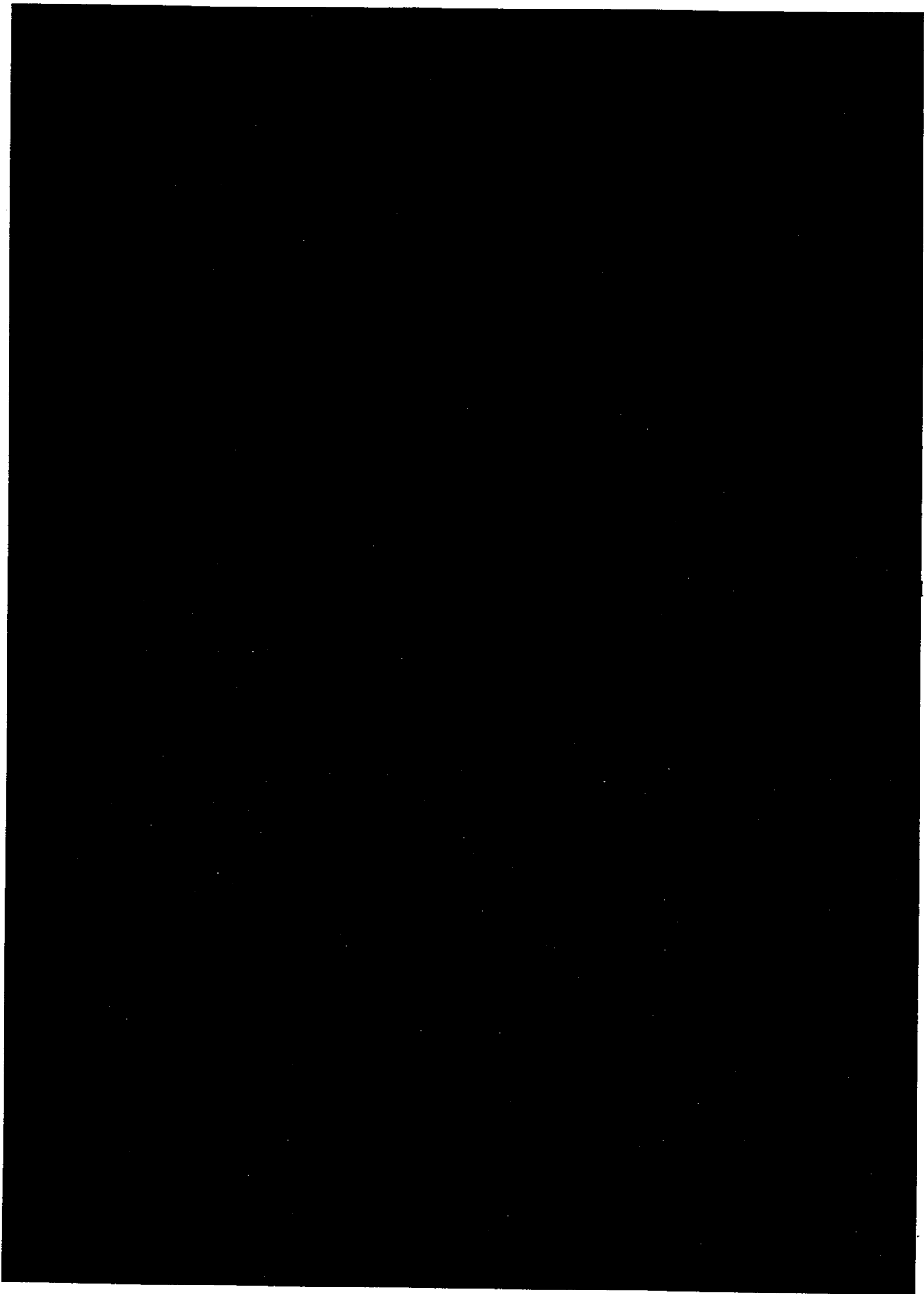


Exhibit C.....Assets Allocated to Finley Products, Inc.



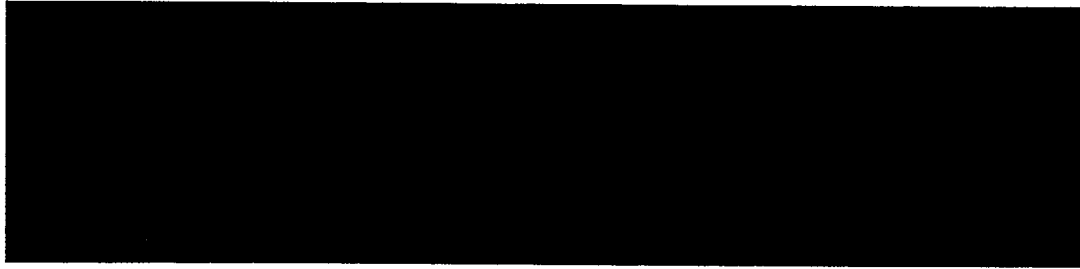






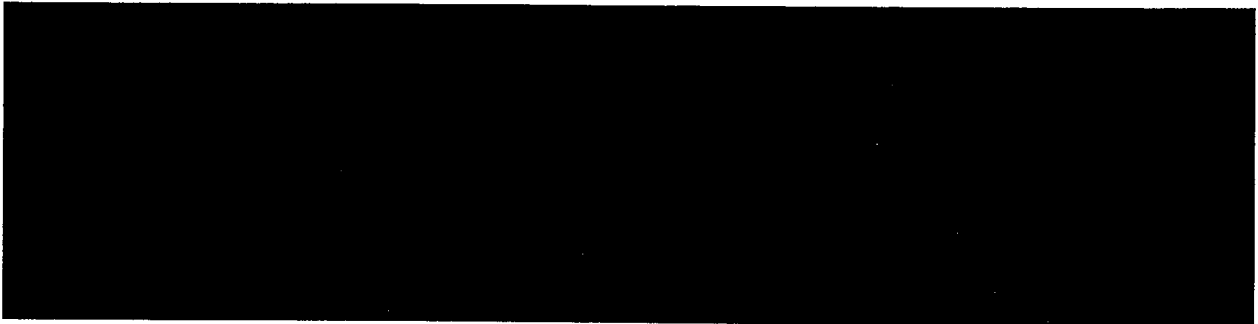
