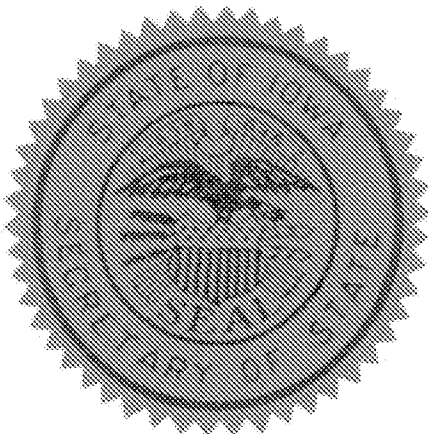

It is hereby certified that:

1. Sara Lee Corporation (hereinafter sometimes referred to as the "Corporation") is a business corporation of the State of Maryland.
2. The Corporation is the owner of all of the units of interest of Metz Baking Company, L.L.C., which is a limited liability company of the State of Iowa.
3. The laws of the jurisdiction of organization of Sara Lee Corporation permit the merger of a business corporation of that jurisdiction with a limited liability company of another jurisdiction.
4. The Corporation hereby merges Metz Baking Company, L.L.C. into the Corporation.
5. The following is a copy of the resolutions adopted on October 24, 2004 by the Board of Directors of the Corporation:

RESOLVED, that the Board of Directors hereby approves the merger (each, a "Merger") into the Corporation of any subsidiary that is wholly owned by the Corporation (the "Subsidiary"), which Merger is approved in writing by one or more officers of the Corporation (the "Officers") and is effected on substantially the following terms and conditions (in addition to any other terms and conditions that may be set forth in an agreement and plan of merger executed by the Subsidiary and the Corporation that are not inconsistent with the following): The Subsidiary shall be merged with and into the Corporation and the separate corporate existence of the Subsidiary shall cease; all of the outstanding shares of stock or units of the Subsidiary are cancelled in the Merger; the Merger does not result in any amendment to the charter or bylaws of the Corporation or any change, in any respect, to the contract rights of any stock of the Corporation; all assets and liabilities of the Subsidiary at the effective time of the Merger shall become assets and liabilities of the Corporation; and the effective time of the Merger shall be the time at which articles of merger are accepted for record by the State Department of Assessments and Taxation of Maryland, or such later time (not to exceed 30 days thereafter) as shall be specified in the articles of merger; and

FURTHER RESOLVED, that the Officers of the Corporation, or any of them, are hereby authorized and directed to execute any agreement and plan of merger and articles of merger, and to take all actions necessary or advisable for the proper filing of the articles of merger with the State Department of Assessments and Taxation of Maryland and with the secretary of state (or other proper authority) of the state or other jurisdiction in which the Subsidiary is incorporated or organized, and to take any other action, and execute, deliver, file and perform any instrument, certificate, receipt, consent, waiver, instruction, agreement, power of attorney, guarantee or other document as may be deemed necessary or advisable for the implementation and consummation of each Merger.

6. The Corporation does hereby agree that it may be served with process in the State of Iowa in any proceeding for enforcement of any obligation of Metz Baking Company, L.L.C., as well as for enforcement of any obligation of this Corporation arising from the merger herein provided for; does hereby irrevocably appoint the Secretary of State of the State of Iowa as its agent to accept service of process in any such proceeding; and does hereby specify the following address without the State of Iowa to which a copy of such process shall be mailed by the Secretary of State of the State of Iowa:



The Corporation shall cause to be executed and filed and/or recorded the documents prescribed by the laws of the State of Iowa, by the laws of the State of Maryland, and by the laws of any other appropriate jurisdiction and will cause to be performed all necessary acts within the jurisdiction of organization of Metz Baking Company, L.L.C. and of this Corporation and in any other appropriate jurisdiction.
