Recitals

1. Worldwood Industries, Inc. ("Worldwood"), is an Oklahoma corporation having a principal place of business at 7509 Southwest 44th Street, Oklahoma City, Oklahoma 73179.
2. Hobby Lobby Stores, Inc. ("Hobby Lobby"), is an Oklahoma Corporation having a principal place of business at 7707 Southwest 44th Street, Oklahoma City, Oklahoma 73179.
3. Worldwood is the owner of the trademark CRAFTY CANDLES ("Mark").
4. Worldwood first used the Mark in commerce on September 1, 2000.
5. Worldwood successfully registered the Mark with the United States Patent and Trademark Office ("USPTO") on August 27, 2002.
6. The USPTO assigned the Mark U.S. Reg. No. 2,613,282 ("Registration").
7. Hobby Lobby desires to acquire the Mark and continue its use in commerce with the goods set forth in the Registration.
8. Worldwood desires to assign to Hobby Lobby any and all of Worldwood's rights, title and interest in the Mark, including without limitation the aforementioned Registration and any subsequent renewals of the Mark and the good will symbolized by and associated with the Mark.

Assignment



the use of the Mark together with the good will symbolized by the Mark, including, but not limited to, any and all right and title held by Worldwood in U.S. Reg. No. 2,613,282 and all subsequent renewals, all common law rights in the mark, and the all rights to recover damages for any past or future infringement of the Mark.
