This Assignment may be executed in counterparts, each of which shall constitute an original, but which together shall constitute one and the same instrument.

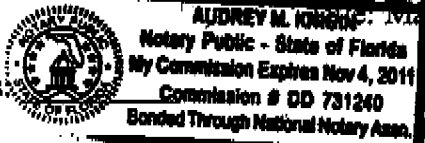

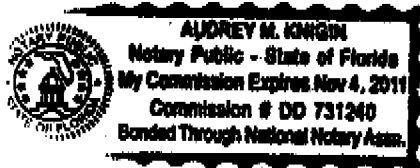
