TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is made and entered into as of this 12th day of March, 2008 between LCB Interim, Inc., a Pennsylvania corporation with a principal place of business at 5 Whitefield Lane, Lancaster, Pennsylvania 17602 ("Transferor"), and National Penn Bank, a Pennsylvania corporation with a principal place of business at Philadelphia and Reading Avenues in Boyertown, Pennsylvania 19512 ("Transferee").

AGREEMENT

NOW THEREFORE, in consideration of the mutual promises and covenants made herein and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:

- (A) Transferor hereby assigns, transfers and conveys to Transferee all right, title and interest in and to U.S. Trademark Registration No. 2,553,043 entitled HOMETOWNE HERITAGE BANK® including without limitation all common law trademark rights, together with all goodwill of the business symbolized by and associated with the Trademark.
- (B) Transferee hereby assumes all liabilities and obligations, and acknowledges existing encumbrances, if applicable, existing or arising in connection with the assignment described in Paragraph (A) hereof, except as otherwise agreed in writing by the parties.
- (C) Without limiting the foregoing provisions, Transferor agrees to take whatever further action is deemed necessary or appropriate by Transferee to properly and completely effect the transfer to Transferee of the Trademark and to establish full custody and ownership of such Trademark by Transferee.
- (D) This Trademark Assignment Agreement shall be governed by the internal laws of the State of Pennsylvania, without reference to its conflict of laws principles.

IN WITNESS WHEREOF the parties hereto, through their respective authorized officers, have executed this Trademark Assignment Agreement as of this 12th day of MARCH, 2008 and affixed their respective corporate seals hereto.
