WHEREAS, INTERNATIONAL PAPER COMPANY (hereinafter "IPC") is a corporation organized under the laws of the state of New York, USA and having an office in Memphis, Tennessee; and

WHEREAS, IPC was prior owner of the Mark pursuant to the Merger executed on December 30, 1988, and recorded on July 10, 1989 in the PTO on Reel 0660, Frame 0580.

NOW THEREFORE, IPC hereby declares that the Assignments executed on January 3, 2002, and November 5, 2004, and recorded on May 13, 2002, and November 8, 2004, in the PTO on Reel 2507, Frame 0184, and Reel 2973, Frame 0166, respectively, inadvertently listed the Mark and the present Correction hereby corrects the misfiling. IPC further declares that it had no right, title, or interest in the Mark or the goodwill symbolized thereby at the time it filed the Assignments recorded May 13, 2002, and November 8, 2004, and presently has no right, title, or interest in the Mark or the goodwill symbolized thereby. Any right, title, or interest in the Mark inadvertently assigned by IPC is hereby reassigned to FABRENE, INC.
