

Sigma Electric Manufacturing Corporation, a corporation organized and existing under the laws of the State of Delaware (this "Corporation"), does hereby certify:

FIRST: The name and state of incorporation of each of the constituent corporations (the "Constituent Corporations") are as follows:

(a) The name of the surviving corporation is Sigma Electric Manufacturing Corporation, a corporation organized and existing under the laws of the State of Delaware.

(b) The name of the corporation being merged into the surviving corporation is Sigma Electric Manufacturing Corporation, a corporation organized and existing under the laws of the State of Louisiana ("Sigma Louisiana").

SECOND: The Agreement and Plan of Merger, dated as of March 20, 2008 (the "Merger Agreement"), by and among the Corporation and Sigma Louisiana, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with the requirements of Section 12:112 of the Business Corporation Law of the State of Louisiana.

THIRD: In accordance with the Merger Agreement, Sigma Louisiana will merge with and into this Corporation. Following the merger, this Corporation will continue as the surviving corporation (the "Surviving Corporation") and the separate corporate existence of Sigma Louisiana will cease. The name of the Surviving Corporation of the merger is Sigma Electric Manufacturing Corporation.

FOURTH: The certificate of incorporation of the Surviving Corporation shall be the certificate of incorporation of this Corporation.

FIFTH: The executed Merger Agreement is on file at an office of the Surviving Corporation, the address of which is 120 Sigma Drive, Garner, NC 27529.

SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any Constituent Corporation.



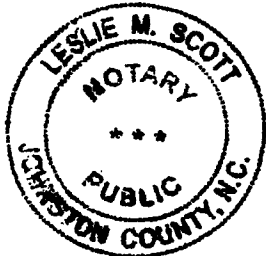
