## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (“Assignment”) is executed as of the 26<sup>th</sup> day of March, 2008, by Centex Corporation, a Nevada corporation (“Centex Corp.”), in favor of MDR South Peak, LLC, a Texas limited liability company (“Assignee”), pursuant to the terms of the Purchase and Sale Agreement dated as of March 18, 2008, between Centex Homes, a Nevada general partnership, and MAC Destination Resorts, LP, a Texas limited partnership (the “Purchase Agreement”). Capitalized terms used, but not otherwise defined, in this Assignment shall have the meanings ascribed to them in the Purchase Agreement.

1. For good and valuable consideration as specified in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, Centex Corp. hereby assigns, effective as of the Effective Time and free and clear of all Encumbrances other than Permitted Exceptions, to Assignee and its successors and assigns, all of Centex Corp.’s right, title and interest in and to the marks set forth on Exhibit 1 to this Assignment (the “Marks”), along with the goodwill of the business symbolized thereby and the right to recover damages and profits for past infringement thereof.

2. This Assignment is subject to the terms and conditions of the Purchase Agreement (including without limitation the representations, warranties, covenants, agreements and indemnities relating to the Marks), which are hereby incorporated into this Assignment by this reference. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms of this Assignment, the terms of the Purchase Agreement shall govern.


