This Assignment constitutes the entire agreement between the parties related to the subject matter hereof and supersedes all prior or contemporaneous representations, discussions, negotiations, conditions and agreements, whether written or oral relating to the subject matter hereof and may be amended only by a writing signed by an authorized representative of each party. This Assignment is governed by and shall be construed in accordance with the laws of the State of Delaware and shall be binding upon and inure to the benefit of the parties and their respective successors and assigns.

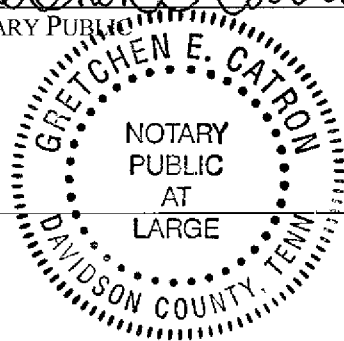

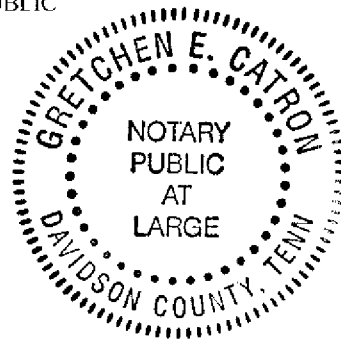
