CONFIRMATORY ASSIGNMENT OF TRADEMARKS

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR ratifies and reaffirms *nunc pro tunc* the assignment to ASSIGNEE of the TRADEMARKS, the entire business or portion thereof to which the TRADEMARKS pertain, and the entire right, title and interest in and to the TRADEMARKS together with the goodwill of the business associated with the TRADEMARKS throughout the world; and

ASSIGNOR, does also hereby sell, assign, convey, transfer and deliver unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARKS, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representative;

ASSIGNOR hereby authorizes and requests that the Commissioner of the United States Patent and Trademark Office, and any official of any country or countries foreign to the United States, whose duty is to issue trademarks or other evidence or forms of intellectual or industrial property protection on applications or registrations, as shown herein, to issue the same to
