**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK COLLATERAL**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL ("Release") made as of the 28th day of March, 2008, by **PNC Bank, National Association**, as Agent for itself and the Banks under the Credit Agreement (defined below) (in such capacity, "Agent"), for the benefit of **Hudson News Company**, a New Jersey corporation ("HNC"), and **Airport Management Services, LLC**, a Delaware limited liability company ("AMS" and, together with HNC, the "Grantors"). Capitalized terms not otherwise defined herein, shall have the meanings ascribed to them in the Credit Agreement (as defined below) and the Loan Documents.

WITNESSETH:

WHEREAS, pursuant to (A) that certain Credit Agreement, dated as of December 4, 2003, as amended and restated by that certain Amended and Restated Credit Agreement, dated as of December 14, 2005 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among HNC and AMS, as borrowers, Hudson Media, Inc., as guarantor, the other Guarantors party thereto, the Banks party thereto, Manufacturers and Traders Trust Company, as syndication agent, Citibank FSB, as documentation agent, KeyBank National Association, as managing agent and the Agent, as administrative agent, and (B) that certain Security Agreement, dated as of December 4, 2003 (the "2003 Security Agreement") as amended and restated by that certain Amended and Restated Security Agreement (Borrowers) dated as of December 14, 2005 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "2005 Security Agreement" collectively with the 2003 Security Agreement), among HNC, AMS and the Agent in favor of Agent, the Grantors granted, pledged and assigned to Agent, for the benefit of the Agent, the Banks and their respective Affiliates a lien on and a security interest in all of Grantors' right, title and interest in and to the to the Trademarks (as defined in the "Security Agreements");

WHEREAS, the 2003 Security Agreement was recorded with the U.S. Patent and Trademark Office at Reel 2761, Frame 0160 on December 9, 2003;

WHEREAS, the 2005 Security Agreement was recorded with the U.S. Patent and Trademark Office at Reel 3210, Frame 0820 on December 15, 2005; and

NOW, THEREFORE, in consideration of the premises and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:


Agent, for the benefit of itself, the Banks and their respective Affiliates, does hereby release and terminate all liens and security interests in the below described properties of Grantor which were assigned, pledged and granted to Agent, for the benefit of the Agent, the Banks and their respective Affiliates, under and pursuant to the 2003 Security Agreement and the 2005 Security Agreement including (a) all of Grantor's Trademarks set forth on Schedule I attached hereto; (b) all reissues, continuations or extensions of the foregoing; (c) all goodwill of the

business connected with the use of, and symbolized by, each Trademark; and (d) all products and proceeds of the foregoing.
