**TRADEMARK ASSIGNMENT**

AND ASSIGNOR HEREBY covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

AND ASSIGNOR HEREBY further covenants and agrees that it will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to ASSIGNOR respecting said marks listed on attached Exhibit "A", and testify in any legal proceeding, sign all lawful papers, make all rightful oaths and generally do everything possible to aid the said

ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper trademark protection for said marks listed on attached Exhibit "A" in all countries.

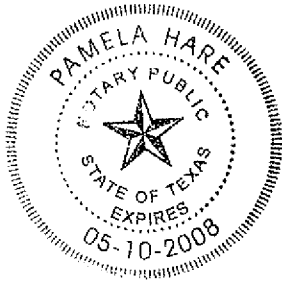
