RELEASE OF SECURITY INTEREST

WHEREAS, Fiberglass Engineering Incorporated, a Kansas corporation, headquartered in Neodesha, Kansas ("Debtor"), and Boatmen's First National Bank of Kansas City, a national banking association ("Lender") are parties to a security agreement executed March 5, 1992, that granted to Lender a security interest in Debtor's assets listed in the attached Schedule A ("Trademarks and Patents");

WHEREAS, Bank of America, N.A., a national banking association headquartered in Charlotte, North Carolina, ("Successor Lender") is the successor in interest to Boatmen's First National Bank of Kansas City;

WHEREAS, Debtor has fully satisfied all of Debtor's obligations to Lender and Successor Lender and accordingly, Lender's security interest in the Trademarks and Patents has terminated;

Successor Lender hereby certifies that Debtor has satisfied all obligations for which the security interest in the property identified in Schedule A was given and hereby terminates the security interest in all of the property identified in Schedule A.
