In order to make and record a specific formal Assignment of the Trademark from Assignor to Assignee as of the date set forth below, be it known that for and in consideration of the sum of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignor, Assignor does hereby sell, assign, transfer and set over to Assignee, and its successors and assigns, the entire right, title and interest in and to the Trademark and U.S. Registration No. 2,092,034, together with that portion of the goodwill of its business associated therewith, and all claims for past damages by reason of infringement of said Trademark and with the right to sue for and collect the same for Assignee's own benefit and for the benefit of its successors, assigns and other legal representatives.
