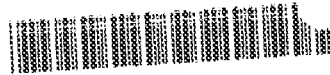

CORRECTED ASSIGNMENT

This Corrected Assignment corrects an error in the assignee which appeared in a prior Assignment document executed and previously recorded in the U.S. Patent and Trademark Office. On August 18, 1997, an Assignment for U.S. Trademark Registration No. 1,071,648 was recorded which named the assignee of the registration as GPOA, a Delaware Limited Company. Due to an error in the recordation form cover sheet, the assignee was recorded as GPOA, a Delaware Limited Partnership. This Assignment was recorded in the U.S. Patent and Trademark Office on Reel 1621, Frame 0953. On November 10, 1997, a corrected recordation form cover sheet and copy of the originally recorded Assignment document were recorded with the U.S. Patent and Trademark Office, to reflect the assignee as GPOA, a Delaware Limited Company. This correction was recorded on Reel 1657, Frame 0023. It has since been discovered, in fact, the assignee was incorrectly identified in the original Assignment document. The parties wish to correct and confirm the assignment of Trademark Registration No. 1,071,648 from Gummed Papers of America to GPOA, L.P., a Delaware Limited Partnership.

WHEREAS, Gummed Papers of America, a corporation of the state of Illinois, was the sole owner of all right, title and interest in and to U.S. Trademark Registration No. 1,071,648 for GUMMED PAPERS OF AMERICA ("the mark"), along with the goodwill symbolized by said mark;

WHEREAS, on August 12, 1997, GPOA, L.P., a limited partnership of the state of Delaware, having a principal place of business at 1333 South Jefferson Street, Chicago, Illinois 60607, acquired the entire right, title and interest in and to said mark along with all associated goodwill symbolized by the mark;

WHEREAS, said parties desire to now confirm said sale, assignment, and transfer insofar as it relates to said mark and all goodwill symbolized by the mark;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Gummed Papers of America, by these presents, confirms that effective August 12, 1997, it sold, assigned, transferred and conveyed and as of August 12, 1997, does hereby sell, assign, transfer and convey unto GPOA, L.P., its successors, assigns and legal representatives the entire right, title and interest in and to the trademark detailed above and all goodwill symbolized by the mark, the same to be held and enjoyed by GPOA, L.P. for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives.
